- Young entrepreneurs
- SMEs
- Migrant workers

Focus on Young Workers – Labour market



- Services professions and low-skilled manual jobs
- Sharp increase in the youth unemployment rate in the EU since the 1st quarter of 2008
- The EU-27 youth unemployment rate twice as high as the total unemployment rate in the 1st quarter of 2009:
 - aged 15-24 unemployment rate - 18,3 %
 - total unemployment rate – 8,2 %

Focus on Young Workers - OSH



- Around 400 workers in the EU under the age of 25 die at accidents at work every year.
- More likely involved in the accidents at work than other age groups
- Direct correlation between accidents at work and experience
