Editorial

ENETOSH is growing! Our partners contributed to this by building up National Networks, e.g. with the promotion of ENETOSH by carrying out presentations and by passing on information material. This newsletter is themed "Making ENETOSH known and assuring sustainability". We would like to present what our partners and we have done in the meantime and which developments are coming up.

Three new "Silent Partners" joined our network. The Macedonian Occupational Safety and Health Association (MOSHA), the Health and Safety Laboratory (HSL) from Great Britain and the Labour Inspection from Austria have been part of the project since November.

International conference of the Austrian Workers' Compensation Board (AUVA) in Vienna

In the context of the European week "Safe Start", the Austrian Workers' Compensation Board (AUVA) organised an international conference under the topic "The Integration of Safety and Health at Work into Vocational Training" in Vienna on 24th October. One day before on 23rd October the AUVA, together with the social partners and the support of the European Agency for Safety and Health at Work, initiated an international safety competition for apprentices in the construction sector under the motto "Construction is teamwork".

The aim of the competition was to promote consciousness for health and safety at work among young employees.



Participants from Austria, Germany, Switzerland, Hungary, Slovakia, Italy, Slovenia and the Czech Republic attended the conference. In the morning of the conference day the

importance of integrating safety and health into initial vocational training was discussed. The fact that young people under the age of 25 represent the age group with the most frequent occupational accidents was taken up consistently. Ways were discussed in which initial vocational training could contribute to the reduction of the accident numbers.

A special highlight was the presentation of the project "team4kids" of the section Industrial Law and Labour Inspection of the Austrian Ministry for Economics and Work. Following a video, experiences in the realisation of sub-projects within the above named were exchanged in dialogue with head masters, students and representatives from the Labour Inspection. The presentation of Patricia Jenner carried out, how innovative projects can contribute to school practice.

Ulrike Bollmann presented the ENETOSHproject and its latest results, but also referred to the future task of assuring sustainability of the project. Kati Masuhr gave further information about the aim and the content of the project at the ENETOSH information stand.

3rd International Seminar of the Section "Education and Training for Prevention" of the International Social Security Association (ISSA)

The 3rd International Seminar of the section "Education and Training for Prevention" of the International Social Security Association (ISSA) took place from 25th to 27th September in Berlin.

Approximately 130 experts from ten nations, representatives of the European Commission, the Federal Ministry for Labour and Social Affairs and the Federal Ministry for Education and Research as well as international organisations like the World Health Organization (WHO) and the International Labour Organization (ILO) discussed the topic "How does the transition from school to work take place?".

The seminar was organised by the Federal Institute for Occupational Safety and Health (BAuA) and the Institute Input. Further partners of cooperation were the French Institut National de Recherche et de Sécurité (INRS), the Canadian Commission de la Santé et de la Sécurité de la Travail (CSST) as well as the Central Federation of Public Sector Accident Insurers (BUK), Germany.

Apart from the demonstration of examples of good practice, the seminar addressed

the issues of conceptual and methodical aspects when risk prevention is integrated. Three aspects were hereby emphasised:

- the health education for students in general education schools
- the training in occupational health and safety for young employees in vocational programs (in institutions or in work/study programs) and
- the integration of young workers into the working life.

On these topics numerous comprehensive and exciting lectures, e.g. the presentation by Heinz Hundeloh from the Municipal Federation for Accident Insurance and Prevention Westfalen Lippe (GUVV) under the topic "An innovative concept for safety and health promotion in school", panel discussions and three collateral workshops, were offered.



During the workshop "On-the-jobintegration" particular emphasis lay on the contribution "Innovative strategies for the prevention of occupational respiratory disorders based on the example of cattle asthma among students at agricultural schools" by Astrid Heutelbeck from the University of Göttingen and the contribution of Marc Schütte "Young workers as knowledgeworkers in companies" from the University of Bremen.

ENETOSH was represented several times during the seminar. Both Ulrike Bollmann (BGAG) and Luisa Carneiro from the Institute for Occupational Health, Safety and Hygiene (IHST) in Portugal contributed to the topic "Instruments and methods to investigate examples of good practice" of ISSA and ENETOSH. Furthermore there was a poster presentation on the ENETOSH network. Additionally, Ulrike Bollmann and Ulrike Craes from the Institution for Statutory Accident Insurance and Prevention in the Health and Welfare Services (BGW) gave further information at the ENETOSH information stand.

TAIEX Seminar on Occupational Safety and Health

From 5th to 6th October a TAIEX seminar on Occupational Safety and Health took place in Zagreb. The Directorate-General for Employment, Social Affairs and Equal Opportunities gave the possibility to present the work of ENETOSH in front of Acceding countries and Candidate countries.



The meeting took place as a first cooperation meeting of the Directorate-General for Employment in collaboration with the Directorate-General for Enlargement. 80 delegates from Bulgaria, Romania, Croatia, Macedonia, Turkey, from Poland, Latvia, Hungary, Ireland, Denmark, France and Germany as well as representatives of the International Labour Organization (ILO), the Finnish Presidency of the European Union, the European Agency for Safety and Health at Work and the European social partners from the construction and agricultural sector were present.

The presentation of ENETOSH contributed to tying the network further at European level, to socialise with potential new members and to get to know new interesting

Interview with Roswitha Melzer, project manager at the "National Institute for Working Life" (NIWL)



Roswitha Melzer is the project manager at the "National Institute for Working Life" in Sweden.

She is engaged in a program aiming at "Working Life in schools" in the department for "Work and Organisation of Work".

She has over 20 years of experience as a former teacher and headmistress.

What is your function at NIWL in Stockholm and which projects are you involved in?

My main function is to mediate between researchers and persons from schools or those, who deal with the conditions of work in schools. We coordinate different networks with representatives of schools and scientists of work in this area. We arrange conferences, seminars and trainings on current topics. Apart from that we provide schools with support on school developing plans. We have developed a digital questionnaire for this, which can be used for the systematic management of the working environment in schools.

Which project has so far been your favourite and why?

This project is called "The School Environment Round" and aims at a model for a cooperation on the improvement of the work environment in schools. The digital questionnaire mentioned before also belongs to this model.

We have published the project "Hearing Health" as an example of good practice on our ENETOSH-platform. Kim Kähäri, your colleague from Gothenburg, has introduced the project "Sound Design" during the 6th "Training and Innovation" in Dresden in 2006. Are the topics hearing and hearing damage of special importance for your institute? What is the background?

There are various reasons for that. In 2003 the University of Umeå published a survey on the sound environment in classrooms. The survey revealed that the acoustic level during lessons was very high. The sound level didn't cause any hearing damages, but it effected the performance, concentration and the language comprehension and was experienced as stressful. A questioning in 1999 concerning the hearing abilities of music teachers showed staggering results. A lot of teachers talked about subjective hearing problems. Furthermore 15 per cent of Sweden's population suffer from tinnitus, of which a further 100 000 have serious problems. Especially the share of young persons with hearing impairments rises.

How did the project "Hearing Health" develop?

Based on these surveys we found it important to teach children and adolescents on how hearing works. The gathering of knowledge on the importance of hearing and the prevention of hearing damages from an early age on, increases the chance that their hearing will be protected by smart decisions and smart acting.

Do teachers, respectively schools, use these informative and helpful materials? What kind of feedback have you had?

The material is very well known and we receive a lot of feedback. 15 000 brochures were distributed and many people have downloaded the pdf-file from our homepage. I reckon, that the material is known at about half of all Swedish schools.

What happens with the results of the project and the material after the NIWL has been shut down?

We are working hard on finding an organisation or agency which will take over the project "The School Environment Round", including the digital questionnaire and the rest of the material. If we are not successful, the material looses its worth.

Which goals and expectations do you have for yourself after the NIWL has been shut down? What are your wishes for the future?

I hope to find a new position, which enables me to keep on engaging in working for good conditions for children and adolescents, be it in school or in society as a whole. You are working in Stockholm, the most beautiful city in Sweden for a lot of people. Which special tip would you give our readers, if they would want to come to Stockholm?

You are right. Stockholm is a beautiful city. What surprises many visitors is the water in and around town. There is as much of it here as in Amsterdam or Venice. One possibility to enjoy this and the typical Swedish food is a visit to Fjäderholmarna, an island near Stockholm. It's 15 minutes away from the city centre by boat. You will find different gourmet restaurants there. Furthermore, it is best to explore Stockholm, like other cities as well, by foot. It is easy to find one's own way with a map and you are able to visit a lot of interesting sights in a short time – history, culture or shopping.
