## Guidelines for Participation in the ENETOSH Call for Videos 2025

#YouthForResilience

---

### 1. General Information

The German Social Accident Insurance (DGUV) is legally responsible for the European Network Education and Training in Occupational Safety and Health (ENETOSH). This competition is organized by ENETOSH (organizer). ENETOSH organizes the **Call for Videos #YouthForResilience** as part of the event ‘Global Crises, Youth and Education: Innovative Approaches to Risk, Resilience, and Resonance.’

- **Date and Venue:** The event will take place on **19 July 2025** during the **Days for Safety, Health, and Wellbeing at EXPO 2025** in Osaka, Kansai, Japan.
  - **Target Group:** Young people aged **15 to 24 years**.
  - **Objective:** To promote creative youth perspectives on how unprecedented global challenges (e.g., climate change, social inequality, pandemics, and geopolitical tensions) impact their lives and how youth resilience can serve as a transformative force.

### 2. Participation Requirements

- Participants must be between **15 and 24 years old**.
  - According to the law of the minor's country, written consent from a parent or legal guardian of the minor is required.
  - Each participant may submit only **one video**.
  - Group submissions are allowed, but one member must act as the **main responsible person**.
  - Participation is **free of charge**.
- 

### 3. Video Requirements

- **Length:** Videos must not exceed **1.5 to 2 minutes**.
- **Content:** Must be youth-friendly, respectful, and free from discriminatory, offensive, or inappropriate material.
- **Copyrights:** All materials (e.g., music, images) must be free of third-party rights.
- **Consent:** Individuals featured in the video must give their consent for publication. For minors according to the law of the minor's country parental or consent of a legal guardian is required.

- **Originality:** Videos must be original works, not previously submitted to other contests.
  - **AI Technologies:** If AI-based technologies are used, this must be explicitly stated.
  - **Accessibility:** Participants are encouraged to include subtitles to promote accessibility.

#### 4. Submission of Videos

- **Upload Method:** Videos should be uploaded via platforms such as Google Drive or WeTransfer.
  - **Submission Details:** Include a short description (max. 150 words) and send it to [contact@enetosh.net](mailto:contact@enetosh.net).
  - **Language:** Videos can be in any language but must include **English subtitles**.
  - **Format:** Acceptable formats include **MP4, MOV**, etc., with a maximum file size of **1 GB**.
  - **Deadline: 30 April 2025.**
  - **Participation Form:** A completed participation form is required. For minors, according to the law of the minor's country, a parent or legal guardian must sign the form.

#### 5. Evaluation Criteria

Submissions will be evaluated based on the following criteria:

- **Content quality, topic relevance, and message clarity:** 40%
  - **Creativity and originality:** 20%
  - **Technical quality:** 20%
  - **Engagement and emotional impact:** 20%
- 

#### 6. Awards and Winner Announcement

- Winners will be selected by an international jury.
- Awards will be given in three age categories: **15–17, 18–21, 22–24**.
- **Announcement:** Winners will be announced and their videos showcased on **19 July 2025** during the ENETOSH event at EXPO 2025. Winners from Japan will be provided with a **1-day ticket for EXPO 2025**.
- **Publication:** Winning videos will be published on [www.enetosh.net](http://www.enetosh.net) and on **LinkedIn**
