#### 2. Data Protection Officer

The DGUV has appointed a data protection officer. You can reach our data protection officer at datenschutzbeauftragter@dguv.de.

### 3. Server log files

We collect data through our servers when you visit our homepage. This data is stored in a so-called server log file and includes your IP address, the date and time of your access, your browser and operating system, the referrer URL and your Internet provider. We delete your IP address immediately after collection and do not merge your IP address with the input data from the study.

# 4. Purposes and legal basis

We do not collect your first or last name as part of the study. If there are few colleges in the state where you work, the small number of responses may result in you or a few other individuals being the originators of those responses. For this reason, we assume that privacy laws apply. In particular, the purpose of the study is to collect data distributed across individual states. We cannot fulfill this purpose if we abandon the breakdown by country.

As outlined in the consent, we process the data entered by you exclusively for the purpose of conducting the study on the basis of consent pursuant to Art. 6 (1) lit. a DSGVO.

You are not obliged to participate in this study. You will not suffer any disadvantages should you decide not to participate.

# 5. Recipients or categories of recipients

The study is evaluated and published. In this process, no personal data is transmitted per se. Due to the fact that the data records can be related to persons, it is possible in individual cases that expert third parties may be able to draw conclusions about your person.

Data will not be transferred to third countries.

# 6. Storage period

We store the data from the study for ten years and delete the collected data immediately afterwards.

## 7. Your rights as a data subject

You are affected by the data processing by DGUV. As a data subject, you have the following rights:

- You have a right to information regarding the data we have stored about you.
- If we have processed incorrect data about you, you may request that this data be corrected.
- You have the right to have data concerning you deleted. The deletion of data concerning you is the consequence of your revocation, which you can declare at any time and without preconditions. However, deletion is only possible as described in the consent until the point in time at which data relating to you is included in an aggregation of data. Subject to the legal requirements, you may also request that we restrict the processing of data relating to you. This is the case, among other things, if you have doubts about the accuracy of the data concerning you or if you prefer the restriction of processing to the deletion of data concerning you.
- You also have the right to receive from us the data you have provided to us in a structured, common and machine-readable format.
- If we process your data based on your consent pursuant to Art. 6 (1) a) DSGVO, you may revoke your consent at any time. Until the time we receive your revocation, the processing remains lawful.
